Further course of action on their appointment will be taken by Pr. The candidates should await for further correspondence from Northeast Frontier Railway in this regard.

**The candidates will have to give an undertaking to Northeast Frontier Railway for undergoing Medical Examination again for ascertaining their medical fitness (suitability) for the post. In case they are not found fit, their candidature will not be considered.** The medical examination will be conducted by the Northeast Frontier Railway as per extant procedure.
