Request for duplicate call letters or any corrections will NOT be entertained on the date of written Examination.** Candidate should bring along with them adequate proof of having submitted application i.e., copy of DD/IPO and two passport size photographs, age proof and caste certificate. It should be noted that duplicate call letters will be issued only to those candidates whose names exist in master list of provisionally eligible candidates.
