Provisional Result of Written Examination for the post of Junior Engineer against GDCE

DOCUMENT VERIFICATION FOR CANDIDATES : GDCE

On the basis of the performance in the Written Examination held on **14.12.2014** the following candidates have been provisionally found eligible to be called for Document Verification (D.V.) for the post of Junior Engineer (JE) against General Departmental Competitive Examination (GDCE). It may be noted that this result is provisional and subject to fulfilling of all relevant eligibility conditions laid down in Notifications under GM(P)/MLG's letter No. E/227/DGCE(M)/Pt. I dated 27.05.2013, E/227/Indent/RRB/Pt-I(E) dated 31.12.2013 and E/227/Indent/2013(N)Pt.V dated 13.02.2014. Roll Numbers are arranged in ascending order and not in order of merit. While every care has been taken in publishing the result, this RRB reserves the right to rectify any inadvertent error or typographical mistake.

At the time of Document Verification, candidates should produce all original certificates and Documents issued by the competent authority for verification of date of birth, educational qualification, mark sheets, caste certificate and non-creamy layer certificate in case of OBC candidates having claimed any relaxation. In case original certificates/mark-sheets have not been received from respective Board/Council/University/Institute then provisional pass certificate and mark sheets issued by the respective Board/Council/University/Institute should be produced. SC/ST candidates must bring Caste/Tribe certificate issued by Competent Authority as prescribed under extant instructions. OBC candidates should bring up-to-date OBC certificate with Non-Creamy layer status from competent authority as prescribed under extant instructions. Please note that OBC certificate with non-creamy layer certification has to be not more than one year old as on the date of document verification.

Candidates belonging to PWD and Ex-SM categories will have to produce original documents in support of their claim.

During DV, the candidates will have to produce their original certificates. The candidature of the candidates not producing their original certificates on the date of DV is liable to be forfeited. However OBC/SC/ST candidates, who fail to produce the original certificate and feature in the UR merit list, will be accepted as UR candidates subject to fulfilling all other requirements for UR.

Candidates must ensure that their name, date of birth, father's name and other particulars in their original certificates match with entries made in their application form. In case of variation in name/father's name/initial etc, Gazette notification or any other legal document as applicable, stating that the name as filled in application and that appearing in the certificates refers to the same person, will have to be submitted at the time of document verification.

Candidates may please note that if they fail to produce the original certificates in support of date of birth/qualification/Caste/community/proof of Ex-Serviceman/proof of PWD etc. on the day of document verification, the candidature is liable to be forfeited without any further notice.

Candidates should bring two self-attested xerox copies of all original certificates and marksheets and other certificates and two recent colour passport size photographs for submission during DV.

Call letters are being dispatched by Speed Post to the candidates individually for appearing in the DV to be conducted in the RRB, Guwahati, Panbazar, Station Road, Guwahati- 781001. This RRB is not responsible for any postal delay or wrong delivery. However, if any candidate does not receive the call letter, he/she may report to RRB, Guwahati on date mentioned against each for duplicate call letter along with counter foil of the call letter of written examination. The candidates may be required to stay for more than one day and they must come prepared for it.

If a candidate is unable to attend Document Verification on the scheduled date and time, then he/she should attend Document Verification on the Block Date for Absentees. No further chance will be given to the candidates for Document Verification.

Note: (I) Call letter for Document Verification does not give any guarantee for employment in Railways. If it is found later at any stage that any candidate does not fulfill any of the conditions of eligibility, his candidature will be cancelled and no appeal against such cancellation will be entertained.
