On the basis of the performance of the 1st Stage Computer Based Test (CBT) for the above-mentioned category held from 22.05.2019 to 02.06.2019 and on 27.06.2019, 2nd Stage CBT held from 28.08.2019 to 01.09.2019 and Documents Verification held from 19.11.2019 to 29.11.2019 and absentee Documents Verification held on 02.12.2019 and 03.12.2019 against CEN-03/2018, the waitlisted/standby candidates with the following Roll Nos. have been provisionally empanelled and their names are being forwarded to **Principal Chief Personnel Officer, Northeast Frontier Railway, Maligaon** for filling up of the vacancies. Further course of action on their appointment will be taken by Pr. Chief Personnel Officer, Northeast Frontier Railway, Maligaon after due verification & ensuring fulfillment of eligibility criteria like production of Original/Current Certificates of Educational Qualification, Date of Birth, Caste, Past Character / antecedents/Affidavits wherever necessary and Medical Tests etc according to the Centralised Employment Notice No. 03/2018. The candidates should await for further correspondence from Northeast Frontier Railway in this regard.

The candidates will have to give an undertaking to Northeast Frontier Railway for undergoing Medical Examination again for ascertaining their medical fitness (suitability) for the post. In case they are not found fit, their candidature will not be considered. The medical examination will be conducted by the Northeast Frontier Railway as per extant procedure.
