Candidates are advised to read the detailed instructions given in the DV e-call letter carefully. 4.0 The candidates called for DV should produce all the original documents along with two sets of photo-copies in A4 size as detailed in the CEN and e-call letter issued for Document Verification. 5.0 Regarding the Document Verification process, candidates are advised to refer to the "NOTICE ON DOCUMENT VERIFICATION PROCESS" uploaded on the website of RRB, Guwahati on 14th September, 2022.

6.0 Those candidates who will be called for Document Verification may note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of RRB, Guwahati on the next day of the DV. The candidates are required to come prepared to stay for three to four days accordingly. Candidates have to pay the prescribed medical fee of Rs 244- only. There are no other charges to be paid to the Hospitals / Health Unit for the medical examination. In rare cases, where the investigations like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital / Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory
