7th Round Document Verification Schedule for Level 2 for CEN 01/2019 - NTPC Graduate & Under Graduate

1.0 A total of 305 candidates (251 in 1st Round, 35 candidates in 2nd Round, 11 candidates in 3rd Round, 5 candidates in 4th Round, 2 candidates in 5th Round & 1 candidate in 6th Round) were shortlisted to appear for DV for Level 2 posts vide notices dated 24.02.2023, 04.04.2023, 24.04.2023, 16.05.2023, 22.05.2023 and 19.06.2023 respectively and the process of Document Verifification (DV) and Medical Examination (ME) of these candidates has been completed.

2.0 Further, candidate with the roll number given below is provisionally shortlisted for the 7th Round Verification of Documents / Certificates & genuineness of candidature and Medical Examination down from the merit list in order to fill the shortfall in empanelment in Pay Level 2 due to absent, rejection, Unfit in Medical Standard etc. Candidates are advised to report to the office of Railway Recruitment Board, Guwahati, Panbazar, Station Road, Guwahati-781001, as per scheduled date and time mentioned below.

3.0 SMS / E-mail alerts are being sent to the candidates' registered mobile / email ID for downloading their e-call letter from the official website of RRB, Guwahati.

4.0 Candidate have to unload his/her signature, latest photograph and identification marks in the portal https://oirms-ir.gov.in/rrbdy/. The instruction for unloading is available in the portal. This portal will be active from 19.08.2023 and upto the date of DV. Candidate is advised to read the detailed instructions given in the DV ecall letter carefully.

5.0 The candidate called for DV should produce all the original documents along with two sets of photo-copies in A4 size as detailed in the CEN and e-call letter issued for Document Verification.

6.0 Regarding the Document Verification process, candidates are advised to refer to the "NOTICE ON DOCUMENT VERIFICATION PROCESS" uploaded on the website of RRB, Guwahati on 14th September, 2022.

7.0 Those candidates who will be called for Document Verification may note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of Northeast Frontier Railway (NFR) on the next day of the DV. The candidates are required to come prepared to stay for three to four days accordingly. Candidates have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals / Health Unit for the medical examination. In rare cases, where the investigations like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital / Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory / hospital.

8.0 The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency deficiency / discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.

9.0 It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in

# IMPORTANT INSTRUCTIONS

1. Candidates must also bring the 02 sets of clear & legible self-attested photocopies each of the original certificates / documents along with e-call letter:

(i) Matriculation / High School Examination certificate or equivalent Certificate as proof of date of birth and Matriculation qualification. (the candidate's name and the father's /mother's name mentioned in the application will be verified with reference to the names mentioned in this certificate). In case of variation in spelling in to name, fathers name in the on-line application and original certificates / documents, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp appears stating that the referred person in certificate(s) so ne & same on the date of verification:

(ii) 10+2 / Inter / Higher Secondary / PUC / Equivalent Certificate (As applicable)

(iii) A University degree or its equivalent.

(iv) Other certificate / diploma as prescribed under minimum educational qualification in Annexure of detailed CEN 01/2019

(iv) The Educational Qualification Certificates viz. Provisional or Regular should contain the date of issue. In case date of issue of these certificates is after the closing date for registration of online application, then the consolidated mark sheet with date of declaration of the result of final qualifying exam or individual mark sheets of all the semesters/years with date of declaration of result on each should be submitted. In case of non-availability of date in any of these mark sheets / certificates, certificates from the testition of the result of lines qualifying exam or individual mark sheets / certificates or the proof of the submitted. In case of non-availability of date in any of these mark sheets / certificates.

3. If a candidate fails to produce the above mentioned original certificates on the date of document verification, his / her candidature is liable to be rejected and no further correspondence will be entertained in the matter. Further, please note that rnishing false information, deliberate suppression of information or using unfair means at any stage of exam will render the candidate disqualified and he/she will be debarred from appearing in any selection or appointment in Ra overnment services and if appointed, the service of such candidate is liable to be terminated in future.

4. It may be noted that merely calling a candidate for Document Verification & Medical Examination does not in any way entitle him / her to an appointment in Railways. Please note that the empanelment will be subject to correctness of all the information submitted by the candidate on-line application, CBT / Skill / Performance Test and verification of documents.

For SC / ST candidates the free travel authority is provided herewith, which may be used for availing free train travel for attending the office of RRB for Document Verification duly producing original caste certificate to authorized railway staff while traveling.
